# City of Iowa Colony Charter Commission Minutes of Meeting March 11, 2020

#### 1. Call to order.

Chair Hargroder called the meeting to order at 9:30 a.m. with a quorum present. Absent included: Marge Madariaga, Rosie Flores, Brenda Dillon, Douglas Chumley. Steven Byrum-Bratsen. Brenda Ledbetter.

#### Pledge of Allegiance.

Chair Hargroder led those present in the Pledge of Allegiance to the U.S. Flag.

#### 2. Comments from the public.

There were no comments from the public. Chief Bell announced the First Responders Day, scheduled for March 14 is postponed. Date to be rescheduled.

- Section 3.02(a)(7). The city Attorney reported that this section is covered under the Election Code. Michael Holton made a motion to delete Section 3.02 a(7) per the City Attorney's recommendation. Timothy Varlack seconded the motion and it carried with one abstention (Tahtinen).
- Section 3.02(b)(3). Rebecca Hester made a motion to approve Section 3.02(b)(3) as amended. Rebecca Barnett seconded the motion and it carried unanimously.

- Section 3.06. Timothy Varlack made a motion to approve Section 3.06(c) as amended. Diana Tahtinen seconded the motion and it carried unanimously.
- Section 3.10(a). Robert Wall made a motion to approve Section 3.10(a) as amended. Rebecca Hester seconded the motion and it carried with one abstention (Ledbetter).

If all requirements of this charter concerning an initiative or referendum by petition have been met by the petitioners, and the city fails to comply with this charter concerning that initiative or referendum, then any petitioner may bring suit in the appropriate district court to require the city to comply with this charter concerning the initiative or referendum.

Diana Tahtinen made a motion to approve the newly added Section 7.14. Timothy Varlack seconded the motion and it carried with one abstention (Ledbetter).

  recommended by the City Attorney. State Law sets this process.
  Rebecca Hester seconded the motion and it carried unanimously.

  - Sections 10.04 and 10.06. Rebecca Barnett made a motion to approve Section 10.04 and 10.06. Michael Holton seconded the motion and it carried unanimously.
  - Sections 10.07 and 10.08. Rebecca Hester made a motion to approve Section 10.07 and 10.08 as amended. Timothy Variack seconded the motion and it carried unanimously.
  - o Timothy Varlack made a motion to approve Article 10 in its entirety as amended. Michael Holton seconded the motion and it carried manimously.
