WORKSESSION – 6:00 P.M.

 Mayor Holton opened the work session at 6:06 P.M. Kent Marsh, Consultant City Planner and the Council discussed amendments to requirements to the Zoning Ordinance for Planned Unit Developments and associated Plan of Developments in the ETJ. Mayor Holton closed the work session at 6:50 P.M.

PUBLIC HEARING-7:00 P.M.

Mayor Holton opened the public hearing on a proposed specific use permit for an electric power generating facility with related administrative facilities located on a 5.568-acre tract of land generally at the Southeast corner of Highway 6 and Louisiana Street in the City of Iowa Colony, Texas, Highway 6. There were no comments from the public. Councilman Byrum-Bratsen stated that this is a good opportunity for the city. Mayor Holton closed the public hearing at 7:53 P.M.
