Motion was seconded by Councilwoman Mudd. Motion was approved unanimously.
- 12. Consider Final Plat approval of Meridiana BCMUD No. 55 Wastewater Treatment Plant, Councilman Myers moved to approve the Final Plat. Motion was seconded by Councilwoman Mudd. The motion was approved unanimously.
- 13 Consider Abbreviated Plat approval of Salazar Estates, Councilman Myers moved to approve the Plat. The motion was seconded by Councilman Holton. Motion was approved unanimously.
- 14. Consider Franchise Ordinance for Phillips 66 Pipeline, Councilman Holton moved to approve subject to holding Notice to Proceed letter until City Attorney notifies city to send Notice to Proceed letter. Motion was seconded by Councilman Myers. The motion was approved unanimously.
- 15 Consider approval of Road and Bridge Inter-local Agreement Fiscal Year 2015. Councilwoman Mudd moved to approve the Inter-local Agreement. The motion was seconded by Councilman Myers. The motion was approved unanimously.

The motion was seconded by Councilwoman Cottrell. Motion was approved unanimously.
- 19. Propose (not adopt) a property tax rate for fiscal year 2014, Councilwoman Mudd moved to propose .49961 property tax rate. The motion was seconded by Councilman Holton. Motion was approve with three ayes and 1 noes. Councilwoman Kay Mudd, Councilwoman Susan Cottrell and Councilman Michael Holton voted yes and Councilman Denny Myers voted no.
- 20 . Set time, date, and place of city council meeting to consider ordinance adopting property tax rate for fiscal year 2014, and authorize notice, Councilwoman Cottrell moved to authorize the city attorney to publish public notice to consider adopting a property tax rate for tax year 2014 on Monday, September 15, 2014, in the City Council Chambers at the Iowa Colony City Hall, 12003 CR 65, Iowa Colony, Texas. The motion was seconded by Councilman Holton. The motion was approved unanimously.
- 21. Consider application of Centerpoint Energy Houston Electric, LLC to amend rate schedule 6.1.1.1.6 Lighting Services in its tariff for retail delivery, Councilwoman Mudd moved to table to check more into it. The motion was seconded by Councilman Holton. Approved unanimously.
- 22. Being no further business, Councilwoman Mudd moved to adjourn. Motion was seconded by Councilwoman Holton. Motion was approved unanimously.
