
- 1 Mayor Robert Wall called meeting to order.
- 2 Pledge of Allegiance was recited.
3. Councilman Myers moved to approve the minutes of February 16, 2015. Motion was seconded by Councilman Selvera. Approved unanimously.


8. Consider and approve ordinance adopting Employee Handbook, Councilwoman Cottrell moved to approve the ordinance. The motion was seconded by Councilman Selvera. Motion was approved unanimously.
9. Consider and approve ordinance adopting Major Thoroughfare Plan, City Planner Kent Marsh gave a presentation of the plan. Mayor Wall opened public hearing for any questions from the floor. Mayor Wall closed the public hearing when all questions from the floor were answered. Councilwoman Cottrell moved to adopt the Major Thoroughfare Plan. Motion was seconded by Councilman Selvera. Motion was approved unanimously.
