BE IT REMEMBERED ON THIS, the 18th day of May, 2015, the City Council of the City of Iowa Colony, Texas, held a Regular Council meeting at the regular meeting place thereof in the city hall there being present and in attendance the following members to wit:

Mayor Robert Wall Councilman Michael Holton Councilman Richard Selvera Councilwoman Susan Cottrell Councilwoman Kay Mudd

and Councilman Denny Myers being absent, constituting a quorum at which time the following business was transacted.

REGULAR MEETING

- 1. Mayor Wall called meeting to order.
- 2. Pledge of Allegiance was recited.
- 3. Councilwoman Mudd moved to approve April 20, 2015 and May 4, 2015 minutes. Motion was seconded by Councilwoman Cottrell. Motion was approved unanimously.
- 4. Mayor Wall thanked everyone on Council and gave an overview on all the projects that were achieved in the past sixteen years. He also addressed the future growth coming to the city.
 - Each Councilmember expressed their thanks for the opportunity to serve on Council.
- 5. First item to accept resignation of Michael Holton as Alderman, Position 2, Councilwoman Mudd moved to accept his resignation. Motion was seconded by Councilwoman Cottrell. Motion was approved unanimously.
- 6. Next item to consider ordinance canvassing general election of May 9, 2015,

Councilwoman Mudd moved to approve the ordinance. Motion was seconded by Councilman Selvera. Motion was approved unanimously.

- 7. Elected officials were sworn in by Judge Herman Atchison.
- 8. Mayor Michael Holton stated he is looking forward to working with Council and to the future of the city growth. Mayor Holton commented on the leadership of Mayor Wall and for his great insight of the future of the city.
 - Each new councilmember expressed their feelings for the opportunity and looking forward in helping the city grow.
- 14. Mayor Holton moved up item14 to consider approval of Sterling Lakes at Iowa Colony County Road 48 (Phase 2) preliminary plat before going to executive session.
 - Councilman Hosey moved to approve the preliminary plat. Motion was seconded by Councilwoman Bradbery. Motion was approved unanimously.
- 9. Council adjourned to Executive session under Texas Government Code section 551.074 at 8:30 p.m. to deliberate:
 - a. Appointment to fill vacancy for unexpired term of Alderman, Position 2.
 - b. Appointment of Mayor Pro Tem.
 - c. Appointment to Planning Commission.

Council returned to open session at 9:05 p.m.

- Consider appointment to fill vacancy for unexpired term of Alderman, Position 2, Councilwoman Cottrell moved to appoint Debbie Gregory. Motion was seconded by Councilman Hosey. Councilwoman Bradbery and Councilwoman Smajstrla voted against and Councilwoman Cottrell and Councilman Hosey voted for. Mayor Holton broke the tie by voting for. Motion was approved to appoint Debbie Gregory.
- 11. Consider appointment of Mayor Pro Tem, Councilman Hosey moved to appoint Councilwoman Susan Cottrell. Motion was seconded by Councilwoman Bradbery. Motion was approved with 3 ayes and Councilwoman Cottrell abstaining.
- 12. Consider accepting resignation(s) from Planning Commission, there were none.
- 13. Consider appointments to Planning Commission, Councilwoman Bradbery moved to appoint Councilman Les Hosey and Robert Wall. Motion was seconded by Councilwoman Smajstrla. Motion was approved with 3 ayes and Councilman Hosey abstaining.

Being no further business, Councilwoman Cottrell moved to adjourn. Seconded by Councilman Hosey. Motion was approved unanimously.
