## **REGULAR MEETING**

- 1. Mayor Holton called meeting to order.
- 2. Pledge of Allegiance was recited.
- 3. Councilwoman Gregory moved to approve September 21, 2015 minutes. Motion was seconded by Councilman Hosey. The motion was approved unanimously.

- 8. First item to consider approval of preliminary plat of Old Airline Market, Kent Marsh gave a presentation and recommended to approve. Councilwoman Gregory moved to approve the plat. Motion was seconded by Councilwoman Cottrell. Motion was approved unanimously.
- 9. Next item to consider approval of amendment to Zoning Ordinance and Building Code dumpster regulations, Councilwoman Cottrell moved to approve the ordinance. Motion was seconded by Councilwoman Bradbery. Motion was approved with 4 ayes and 1 naes. Councilman Hosey voted no.
- 10. Next item to approve Letter of Engagement with Whitley Penn to conduct the audit for the fiscal year ending September 30, 2015, Councilwoman Cottrell moved to approve the Letter of Engagement. Motion was seconded by Councilman Hosey. Motion was approved unanimously.
- 11. Next item to approve the Letter of Agreement with Karen Renfrow for Municipal Court Consulting Services, Councilman Hosey moved to approve the Letter of Agreement. Motion was seconded by Councilwoman Bradbery. Motion was approved unanimously.
- Next item to approve the proposal by Addico Consulting for document data archiving, Councilwoman Cottrell moved to approve the proposal by Addico Consulting. Motion was seconded by Councilwoman Gregory. Motion was approved unanimously.
- 13. Next item to accept the infrastructure for the one year maintenance period for Meridiana Sections 1,2,4 and 5, Councilwoman Cottrell moved to approve Meridiana Sections 1,2,4, and 5 with punch list conditions, as recommended by Johnston, LLC, City Engineers, with the one year maintenance period beginning after certification by Johnston, LLC, that all punch list items have been corrected, and authorize recordation of the plat immediately. Motion was seconded by Councilman Hosey. Motion was approved unanimously.
- 14. Next item to consider action to amend the Subdivision Ordinance to allow early platting under certain conditions. No action taken.
- 15. Next item to approve ordinance regulating the use of the city's rights of way, Councilwoman Cottrell moved to approve the ordinance. Motion was seconded by Councilman Hosey. Motion was approved unanimously.
- 16. Next item to authorize Gormly Surveying to conduct a land survey of Duke Cemetery, Councilwoman Cottrell moved to authorize Gormly Surveying to conduct a land survey. Motion was seconded by Councilwoman Bradbery. Motion was approved unanimously.

- 17. Next item to consider interest quotes on investment of city funds, Councilwoman Cottrell moved to roll over certificate at First State Bank. The motion was seconded by Councilwoman Gregory. Motion was approved unanimously.
- 18. Next item to review Quarterly investment report. Council reviewed the report.
- 19. Next item council adjourned to executive session at 8:45 p.m. under Texas Government Code section 551.076 to discuss security devices at city hall.
