BE IT REMEMBERED ON THIS, the 18th day of July, 2016, the City Council of the City of Iowa Colony, Texas, held a Regular Council meeting at the regular meeting place thereof in the city hall there being present and in attendance the following members to wit:

Mayor Michael Holton Councilwoman Kacy Smajstrla Councilwoman Robin Bradbery Councilman Michael Byrum-Bratsen Councilman Les Hosey

and Councilwoman Susan Cottrell being absent, constituting a quorum at which time the following business was transacted.

WORK SESSION:

1. Discussion of proposed Sign Ordinance, Councilwoman Bradbery suggested to add the following to the ordinance: (a) Prohibited Property Activity Signs to Section 4(A), Item 16. (b) Celebratory Signs to the Holiday Sign Section. (c) Agricultural signs exemption for ag uses only in the ETJ.

Representative for Meridiana indicated concerns. Mayor asked for those concerns to be put in writing, meet with staff and put it on the agenda for August.

Discussed proposed FY 17 Annual Budget draft. Discussed the values and tax rate and the spread sheet of the amended FY 16 Budget, year to date expenditures, projected year end expenditures and revenues.

Mayor Holton announced Councilwoman Susan Cottrell is absent preparing for upcoming surgery .He announced the beams on the overpass on SH 288 have been hung across the full length. He attended Meridiana Backyard BBQ event and there are 3 permanent residents and 40 lots have been sold, Carrie O'Neal, the Court Clerk is back part time.

- 12. Consider approval of the 2015 TIRZ 2 Annual Report, Councilman Hosey moved to approve. Seconded by Councilwoman Bradbery. Motion was approved unanimously.
- 13 Consideration and possible action on ordinance authorizing bond requirements for developers affecting city streets, Councilman Hosey moved to table. Seconded by Councilwoman Smajstrla. Motion was approved unanimously.

- 14. Consideration of approval of Preliminary Plats for Sterling Lakes West, Section 3, Councilwoman Smajstrla moved to approve Section 3. Seconded by Councilman Byrum-Bratsen. Approved with 3 ayes and 1 nay. Councilwoman Bradbery voted against the motion.
- 15. Consideration of approval of Preliminary Plat for Sterling Lakes West, Park and Drainage, Councilman Byrum-Bratsen moved to approve as recommended by Planning Commission. Seconded by Councillman Hosey. Motion was approved unanimously.
- 16. Being no further business, Councilwoman Bradbery moved to adjourn. Seconded by Councilwoman Smajstrla. Motion was approved unanimously.
