2. Pledge of Allegiance was recited.
- 3 Consider and take action to approve amending the Agreement by and between the City of Iowa Colony, Reinvestment Zone Number Two, City of Iowa Colony, Texas and the Iowa Colony Development Authority, Councilwoman Cottrell made a motion to approve the amended agreement as recommended by the Iowa Colony Development Authority. The motion was seconded by Councilman Hosey. Motion was approved with Councilman Byrum-Bratsen due to conflict of Interest.

4. Consider and take action to adopt Ordinance amending the City of Iowa Colony Tax Reinvestment Zone Project and Financing Plan, Councilwoman Cottrell made a motion to adopt the Ordinance amending the TIRZ Plan to allow for 100% of the increment into the Fund. The motion was seconded by Councilwoman Bradbery. Motion was approved unanimously, with Councilman Byrum-Bratsen abstained due to conflict of interest. 5. Consider action regarding setting proposed tax rate for 2016, Councilwoman Cottrell moved approval of a proposed tax rate not to exceed \$.4500/\$100 for Fiscal Year 2017. Motion was seconded by Councilman Byrum-Bratsen. Motion was approved unanimously.
6. Being no further business, Councilman Hosey moved to adjourn. Seconded by Councilman Byrum-Bratsen. Motion was approved unanimously.
