PUBLIC HEARING at 7:00 p.m. on budget for the fiscal year beginning October 1, 2017.

Mayor opened the public hearing at 7:00 p.m.

Ron Cox explained the one change in the budget to include last year's street budget amount to this budget since the work won't be done until after October 1, 2017.
