4. Discussed formation of Iowa Colony Crime Control and Prevention District.

5. Council convened in Executive session at 7:42 p.m. under Texas Government Code section 551.074 to deliberate concerning appointment of Temporary Directors of Iowa Colony Crime Control and Prevention District. Returned to open session at 8:02 p.m.
