REGULAR MEETING - 7:00 P.M.

- 1. Mayor Byrum-Brasten called the meeting to order at 7:02 P.M.
- 2. Pledge of Allegiance and Texas Pledge were recited.
- 3. Citizens Comments and Presentations. There were no comments from the public.
- "An opportunity for the public to address City Council on agenda items or concerns not on the agenda. To comply with the Texas Open Meetings Act, this period is not for question and answer. Those wishing to speak must fill out

the sign-up sheet at the entrance to the council chambers prior to the start of the meeting, and observe a three-minute time limit."

- 4. Mayor's comments or reports.
 - Mayor Byrum-Bratsen presented the Fair Housing Month Proclamation.
- 5. Council comments or reports.
 - Councilwoman Cottrell reported that the Iowa Colony High School is really coming along.
 - Councilwoman Murray thanked the Mayor and the First Responders.
 - Councilwoman Bradbery told all to stay safe.
 - Councilwoman Smajstrla thanked everyone.
 - Councilman Wilsey gave no report.
- 6. Staff Reports.
 - A. City Manager
 - Ron Cox reported that the funding for County Road 63 has been switched to County Road 64 to accommodate the AISD Iowa Colony High School traffic and other growth.
 - The walk through that was scheduled for the ball fields has been postponed due to COVID-19 and will be rescheduled for a later date.

- 7. Consideration and possible action to approve an ordinance extending the Mayor's Declaration of Disaster. Councilwoman Bradbery made a motion to approve the ordinance. Seconded by Councilwoman Smajstrla. City Attorney, Larry Boyd pointed out the process. The Mayor signs the Declaration for seven days, the Council extends, then the Mayor has the authority to issue various executive orders. Motion approved unanimously.
- 8. Consideration and possible action to adopt an ordinance postponing the general election of city officers and the special election on a home rule charter from May 2, 2020 to November 3, 2020 in accordance with the proclamation of Governor Abbott, and in response to the COVID-19 virus outbreak. Councilwoman Murray made motion to postpone the election until November 3, 2020. Seconded by Councilwoman Bradbery. Approved with three ayes. Councilwoman Cottrell and Councilwoman Smajstrla voted against the motion.
- 9. Consideration and possible action to order the City Secretary to mail a copy of the proposed home rule charter to each registered voter in the City of Iowa Colony. No action taken.
