BE IT REMEMBERED ON THIS, the 18th day of May, 2020, the City Council of the City of Iowa Colony, Texas, held a Public Meeting via Videoconference at 7:00 P.M. there being present and in attendance the following members to wit:

And Councilwoman Robin Bradbery being absent, <u>constituting a quorum at which time the following business was transacted.</u>

REGULAR MEETING - 7:00 P.M.

- 1. Mayor Byrum-Bratsen called the meeting to order at 7:01 P.M
- 2. Pledge of Allegiance and Texas Pledge were recited.

3. PUBLIC HEARING

- Hold a public hearing for a request for a variance to the Sign Ordinance regarding the
 height and sign area for a monument sign at 3244 Meridiana Parkway along SH 288.
 Mayor Byrum-Bratsen opened the public hearing. Mike Kravitz, the architect of record
 spoke on a point of reason for the monument sign variance. Vernon Wallace was also on
 the line. Michael Holton stated that once you grant a variance it waters down the
 ordinance.
- 4. Citizens Comments and Presentations. Douglas Chumley asked multiple questions in regards to concern about the city and policies. The questions and answers are attached.
- "An opportunity for the public to address City Council on agenda items or concerns not on the agenda. To comply with the Texas Open Meetings Act, this period is not for question and answer. Those wishing to speak must identify themselves and observe a three-minute time limit."
- 5. Mayor's comments or reports.

The parking lot for employees is now complete. We will be canceling the contract with contractor for the inside of city hall. We are monitoring Covid 19 cases and will continue to do so. We will discuss extending the Police Department. The next phase of reopening will allow public into city

hall. The food pantry will be coming to the city on Wednesday. We are seeking volunteers. The sign up is online.

 - Councilwoman Cottrell spoke to Dinh and Rachel in regards to an antique mobile home being brought onto the property on the corner of Davenport and Iowa Colony Blvd. She asked if the city had an ordinance against flood lights being intrusive? Also, thanked Adico for the public works report that was provided to the council.
 - Councilwoman Bradbery was absent.
 - Councilwoman Smajstrla thanked the Police and First Responders for everything they do and for being on the frontline.
 - Councilman Wilsey stated that the city park and ball fields look great.
 - Councilwoman Murray thanked Chief Bell for checking on the council. She stated that she is looking forward to having the next council meeting at City Hall.

Councilwoman Cottrell moved to approve the ordinance. Councilman Wilsey seconded the motion. Approved with four ayes.
- 13. Consideration and possible action to approve the issuance of Series 2020 bonds for the Tax Increment Reinvestment Zone No. 2. Councilwoman Cottrell moved to approve the issuance of bonds. Seconded by Councilman Wilsey. Approved with four ayes.
- 14. Consideration and possible action regarding a request for a variance to the Sign Ordinance for signage for 3244 Meridiana Parkway along SH 288. Councilwoman Cottrell made a motion to deny the variance. Seconded by Councilwoman Smajstrla. Kent Marsh, City Planner spoke to

the variance. The Council denied the variance with three votes. Councilman Wilsey abstained from the vote. Councilwoman Bradbery was absent.

Councilwoman Cottrell made a motion to approve the ordinance amending the Design Criteria Manual. Seconded by Councilman Wilsey. Approved with four ayes.

- 22. Councilwoman Cottrell made a motion to adjourn. Seconded by Councilwoman Murray. Approved unanimously with four ayes. Meeting was adjourned at 8:43 P.M.
