
Meeting- 7:00 P.M.

1. Michael Holton called the meeting to order at 7:00 P.M.
2. Consider approval of the February 5, 2018 Minutes. David Hurst made a motion to approve the minutes as presented. Seconded by Danny Cottrell. Approved unanimously.
3. Michael Holton discussed the Crime Control and Prevention District duties of the Temporary Board.
4. Consider adopting draft of two- year Crime Control Plan. David Hurst made a motion to adopt the draft of two-year Crime Control Plan. Seconded by Brian Powers. Approved unanimously.

5. Consider adopting draft of two – year Crime Control Budget, including proposed sales and use tax of up to one-half percent. Susan Cottrell made a motion to adopt the draft of two-year Crime Control Budget including proposed sales and use tax of up to one-half percent. Seconded by David Hurst. Approved unanimously.
6. Consider proposing sales and use tax for Crime Control Plan and Budget. Danny Cottrell made a motion proposing sales and use tax for Crime Control Plan and Budget. Seconded by David Hurst. Approved unanimously.
7. Consider adopting District regulations. Susan Cottrell made a motion to adopt District regulations. Seconded by Danny Cottrell. Approved unanimously.
8. Consider submitting plan and budget to City Council. Danny Cottrell made a motion to submit plan and budget to City Council. Seconded by David Hurst. Approved unanimously.

Consider ordering election to be held on May 5, 2018 to consider the creation of the Iowa Colony Crime Control and Prevention District dedicated to crime reduction programs and the adoption of a proposed local sales and use tax at a rate of one -half percent.
