1. Call to Order.

Staff presented the financial report in a revised format, as requested by the Board. This report indicates the budget for a particular item, and how much has been spent in that budget to date.

Brenda Dillon made a motion to approve the financial report and invoices since February 8, 2020. Diana Tahtinen seconded the motion and it carried unanimously.

9. Consider staff reports.

Staff reported on the new Central Square RMS to be implemented. The ICPD is going to work with Galveston County to implement this more capable reporting system. There will be a budget amendment to support this cost on the agenda for the next meeting. The cost is just over \$11,000 one time cost for implementation.

Staff also reported on the activities in COVID – Citations have gone down but will start picking back up. Are about to hire a full time Code Enforcement/Animal Control Officer to work for the City. Code enforcement activities will go up, as well.
