NOTICE TO CONTRACTORS: All contractors working in the City are required to register at www.iowacolonytx.gov. Copies of Licenses, Insurance & Bond Information associated with this permit must be on file with the City of Iowa Colony. This permit becomes null and void if construction or work authorized is not commenced within six [6] months of permit date, or if construction is suspended for a period of one [1] year at any time after work is commenced.

If the permit application is approved, a preconstruction meeting and a minimum 48-hours notice is required prior to the start of construction. Additional permits may be required depending on the type of work being performed. Any work performed without a proper permit may result in a fine of double the permit fee.

The granting of a permit does not presume to give authority to violate or cancel the provision of any other state or local law regulating construction or the performance of construction.
