Upon completion of bids and selection of general contractor/s, submit the winning bids/s to the City Engineer. If there is a 10% or more difference between the estimated construction cost and the actual construction cost, fees will be retroactively adjusted.)

SUBMITTAL REQUIREMENTS: Deliver the following items on flash/thumb drive to Iowa Colony. No hard copies required.

- Commercial Site Development Plan Review Application
- Construction cost estimate (signed and sealed by Engineer of Record)
- Payment made payable to the City of Iowa Colony
- Digital copies of entire application including application, construction plans in pdf format, plat (if available), and construction cost estimate on a flash drive

The average plan review time is two to three weeks for initial and resubmittals. On resubmittals, provide a comment response letter and drawings in digital format (no hard copies) to the City Engineer. An additional plan recheck fee of \$350.00 is required for additional reviews after the second submittal. The recheck fee is valid for two reviews.

If plans have not been approved within a calendar year from the date of the initial submittal, a new application and fees are required. Approved plans are valid for one year from the City Engineer's signature. Any revisions to approved plans will require a plan recheck fee.
