Per City of Iowa Colony Ordinance No. 2016-07, before any Fill is placed or Change in Drainage is initiated, the following information must be submitted, along with this completed application and applicable fee, to the City Floodplain Administrator for review:

Application Requirements:

1. Site Plan (overall layout of lots and parcel) showing proposed fill location and depth.
2. Plan showing elevations on the subject property and adjacent property before and after the proposed change.
3. Boundaries of any Flood Zones or Floodways as determined by the applicable FEMA Flood Insurance Rate Map (FIRM). Label location on FIRM map. Clearly indicate Base Flood Elevation (BFE), if within the floodplain.
4. The detailed drainage plan showing the effect of the proposed change signed and sealed by a professional engineer in the State of Texas.
5. Defined contours (0.5'), waterways on or adjacent to the site.
6. Drainage area map showing on-site and off-site draining across or adjacent to the site with calculations of flows.
7. Proposed drainage and maintenance easements.
8. Any other information concerning such action reasonably requested by the City Floodplain Administrator.

Exceptions:

1. This ordinance shall not apply to Fill or Changes in Drainage conducted by the United States of America, the State of Texas, the County of Brazoria, or any other governmental entity, in their respective rights of way.
2. Incidental Dirt Work (one load or less outside the floodplain) shall not require a permit. In no instance shall Incidental Dirt Work adversely affect the drainage of adjacent property.

I hereby certify that I have read & examined this application & know the same to be true & correct. All provisions of laws and ordinances governing this type of work will be complied with, whether specified or not. The granting of a permit does not presume to give authority to violate or cancel the provision of any other state or local law regulating construction or the performance of construction.
