This ordinance shall not apply to Fill or Changes in Drainage conducted by the United States of America, the State of Texas, the County of Brazoria, or any other governmental entity, in their respective rights of way. 2. Incidental Dirt Work (one load or less outside the floodplain) shall not require a permit. In no instance shall Incidental Dirt Work adversely affect the drainage of adjacent property. I hereby certify that I have read & examined this application & know the same to be true & correct. All provisions of laws and ordinances governing this type of work will be complied with, whether specified or not. The granting of a permit does not presume to give authority to violate or cancel the provision of any other state or local law regulating construction or the performance of construction.
