<p>Filing requirements are per state statute, available on the Texas Secretary of State website, and those of the City of Iowa Colony Charter, Article 3, (The City Council Qualifications). Each person who becomes a candidate for mayor or councilmember shall meet the following qualifications:</p> <p>Be a Citizen of the United States</p> <p>Age- 21 years of age or older on the first day of the term to be filled at the election or on the date of appointment, as applicable.</p> <p>Have not been determined by a court exercising probate jurisdiction to be:</p> <ul style="list-style-type: none"> -Totally mentally incapacitated or -Partially mentally incapacitated without the right to vote. <p>Be a qualified voter of the city</p> <p>Have been a resident of the territory from which the office is elected or appointed for 12 months immediately preceding the following date:</p> <ul style="list-style-type: none"> -The date of the regular filing deadline for a Candidate's application for a place on the ballot -For a write in candidate, the date of the election for which the candidate's name is written in -For an appointee to the council, the date of the appointment - If territory is annexed into the city within the 12 month period described in this section, then the person's residence in that territory before the annexation counts toward the residency requirement. 	<p style="text-align: center;">February 18, 2022 By 5:00 P.M.</p>

Candidate Packets, including the application are available in the City Secretary's office the first week of January as well as posted on the city website www.iowacolonytx.gov Candidates are strongly encouraged to obtain a candidate packet. Forms are available on the Secretary of State website and the Texas Ethics Commission website but the full Candidate Packet is obtained from the City Secretary.
