

ORDINANCE NO. 2019-11

AN ORDINANCE OF THE CITY OF IOWA COLONY, TEXAS, MAKING FINDINGS OF FACT; DECLARING THE CITY'S POPULATION TO BE OVER 5,000; DECLARING THE RESULTING EXTRA TERRITORIAL JURISDICTION TO BE ONE MILE; AND PROVIDING A SAVINGS CLAUSE, SEVERANCE CLAUSE, AND EFFECTIVE DATE.

WHEREAS on April 1, 2019 the City Council of the City of Iowa Colony recently adopted Ordinance 2019-?? annexing into the city limits all the territory contained in Brazoria County MUD 31 (BCMUD31); and

WHEREAS the City Council used as a basis for finding in the adoption of that ordinance the following documents in determining the population of the City of Iowa Colony on that date;

1. City of Iowa Colony Determination of Population as of November 11, 2018 for Annexation of BCMUD 31 ("Determination of Population");
2. Mid-Year Population Estimates for H-GAC Region Cities, Source U.S. Census Bureau, Released: May 2018 ("HGAC and US Census Report");
3. Brazoria County MUD No 55 Connection Report, November 2018 ("MUD No. 55 Connection Report"); and
4. Brazoria County MUD 31 Connection Report, October 2018 ("MUD No 31 Connection Report").

WHEREAS the population of the City of Iowa Colony after the annexation of MUD 31 was found to be 6,185 on April 1, 2018.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF IOWA COLONY, TEXAS:

1. Findings of Fact

The City Council of the City of Iowa Colony, Texas, ("the City") finds that all procedures, prerequisites, and requirements of law concerning this ordinance and the statutes associated with this law herein have been satisfied.

2. Declaring the City's population to be over 5,000

The City Council hereby adopts the attached exhibit as the standard for the city's population as of the date of the annexation of MUD 31 on April 1, 2019, Ordinance No 2019-?? And declared the population to be over 5,000.

4. The City Council acknowledges and declares that as a result of the increase in population to over 5,000, the city's extra territorial jurisdiction (ETJ) extends from one-half to one mile from the city limits lines or to the city limits or ETJ lines of adjacent cities that may have been established before the date of the annexation.


5. Severance Clause
